Mr. Simmons moved and Mr. Mercer seconded the motion to create the Miami County Non-Profit COVID-19 Recovery Grant Program, to be administered by the Miami County Department of Development, in accordance with the criteria set forth herein and as attached hereto. Further authorize the Miami County Department of Development to proceed with the allocation of \$150,000 for Round One (2022) of the grant program. The COVID-19 pandemic has been detrimental for many local non-profit organizations and their employees, and the Miami County Board of Commissioners wish to use available ARPA funds received to establish the Miami County Non-Profit COVID-19 Recovery Grant Program to lessen the economic damage caused by the pandemic. Effective February 1, 2022 through January 31, 2023. Costs to be paid from Fund 103.

Services will include mowing and basic trimming, fertilizer/weed applications and management of preemergent and post vegetation control. Costs shall not exceed \$3,115.00. To be paid from Fund 106. The term of this Contract is April 1, 2022 through October 31, 2022. This is the first renewal of the prior contract. Said Contract may be renewed for an additional one-year term, based upon satisfactory performance and available funding. The funds will be used to help purchase new Self-Contained Breathing Apparatuses, Cylinders, face-pieces, and other equipment, as current apparatuses are rapidly aging past any ability to adequately be maintained in an operational state. The Casstown Community Volunteer Fire Department shall make an audited account of any funds received from the County and provide this information to the County.
